g. According to Section-34 of Appendix-8 (Rule-234, Note-2) of BSR Part-1 the leave will have to be commenced within 35 days; otherwise the leave will be void.

3. To be noted that, **Ms. Munira Sultana**'s Husband Mr. Md. Saidul Anwar will accompany her during this travel.
