
Government Order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh in favor of Dr. Satyajit Ghose, Chief Scientific Officer and Project Director of Bangladesh Atomic Energy Regularity Authority to attend the 8th Review Meeting of the Contracting Parties to the Convention on Nuclear Safety at the International Atomic Energy Agency (IAEA), Vienna, Austria during 23 March to 3 April 2020.

2. Terms and conditions:

- (i) While participating in the aforesaid program and on journey to and from the Austria he will be treated as on duty.
- (ii) He will draw his pay and allowances in local currency. No part of it shall be drawn in foreign currency.
- (iii) All expenses of this program will be borne from the 'Development of Nuclear Regularity Infrastructure for Bangladesh Atomic Energy Regularity Authority to Supervise the Nuclear Safety of Rooppur Nuclear Power Plant'-Project
- (iv) He will leave Dhaka for Austria on 22nd March 2020 or on a nearby date and will leave Austria for Bangladesh on 3rd April 2020 or a nearby date.
