- The delegation will leave Dhaka for Australia on 25 April 2024 or on a nearby date and the members of the delegation (Sl. 2-3) will leave Australia for Dhaka on 04 May 2024 or on a nearby date. After the personal visit The Honorable Minister will leave Australia for Dhaka on 14 May 2024 or on a nearby date.


