- (ii) They will participate in signing control point, closing the quality plan and signing readiness for manufacturing the LTME as per quality plan and will sign the sheet for agreement & approval of inspection results as well as signing the certificate on acceptance inspection.
- (iii) They will perform any duty/Inspection in any city in Russian Federation assigned time to time officially by Bangladesh Atomic Energy Commission.
- (iv) They will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency.
- (v) They will be accommodated at the rental house arranged from 'Construction of Rooppur Nuclear Power Plant'-Project in Russian and except accommodation all other expenses will be borne from the 'Construction of Rooppur Nuclear Power Plant'-Project as per existing rules.
- (vi) They will leave Dhaka for Russia on 31 January, 2020 or on a nearby date and will leave Russian for Dhaka on 02 May, 2020 or nearby date.
